

## Gifts to Fundación Cimientos by U.S. Donors

Cimientos is committed to minimize costs and maximize the use of donations on programs benefiting low income children and schools. Cimientos has determined that, at present, the most cost effective means for accepting tax-deductible donations from U.S. taxpayers is via *donor advised gifts*. A *donor advised gift* is a donation made to a grant making organization in the U.S. that will follow the donor's recommendation as to the application of the funds to a qualified charitable organization.

Cimientos has been determined as eligible to receive *donor advised gifts* from the Charities Aid Foundation America ("CAFAmerica"). CAFAmerica is a tax-exempt U.S. charity whose purpose is to support, promote and facilitate global philanthropy. Gifts to CAFAmerica are eligible for the maximum tax benefits allowed under U.S. law. In compliance with U.S. tax law, all donor recommendations made to CAFAmerica are non binding and must be approved by CAFAmerica's Board of Directors. However, to ensure that gifts to CAFAmerica are tax-deductible and that CAFAmerica fulfills its responsibilities as a 501(c)(3) tax-exempt, not for profit organization, CAFAmerica maintains complete control and discretion over the use of the funds they receive.

Donors interested in supporting Cimientos may make a *donor advised gift* to CAFAmerica with the recommendation that the funds be granted to Cimientos. Donations may be made by check or credit card. Donors are requested to complete the attached CAFAmerica Gift form and submit it with their donation. CAFAmerica administrative costs associated with an individual donation are 8% of the first \$25,000, 4% of the next \$75,000 and 1% of all funds over \$100,000 per single donation. These costs will be deducted from your gift.

**ATTENTION:** Effective March 15th 2006, CAFAmerica will only accept single donor advised gifts of \$500 or more. Donations sent to CAFAmerica after this date of less than \$500 as a one-off Donor Advised Gift (DAG) will be returned to the donor.
